

Multiple-Entry Holiday Visa Requirements for Citizens of Indonesia, the Philippines and Vietnam

(as of 15/12/2025)

ELIGIBILITY

Nationals of Indonesia, the Philippines, and Vietnam with ordinary MRP (Machine Readable Passport)/e-passport in compliance with the ICAO (International Civil Aviation Organization) standard, who wish to apply for a Multiple-Entry Holiday Visa for a stay of up to 30 days and are applicable to one of the following categories:

1. Individual who has travel record as temporary visitor to Japan in the last three years and who has ability to pay the travel expenses.
2. Individual who has travel record as temporary visitor to Japan and also travel records as temporary visitor to G7 countries (other than Japan) in the last three years.
3. Individual with sufficient financial capacity.
4. Spouse or children of the individuals who are mentioned in (3.) above OR those whose spouse or parents currently hold a valid multiple-entry visa for Japan (please refer to document *12).
5. Visa applications are accepted **only from residents in QLD** residing in postcodes 4000-4805 and 4829. *Residents residing in postcodes 4806-4828 and 4830-4895 must contact and lodge their applications with the Cairns office https://www.brisbane.au.emb-japan.go.jp/itpr_en/about_cairns.html.*
6. **Only those with a long-term resident status in Australia** can apply for a visa. e.g. Permanent Resident, Work, Student etc.

LIST OF REQUIRED DOCUMENTS

1. **A valid passport (MRP/e-passport in compliance with the ICAO standard only)**
2. **A valid Australian visa linked to your current passport number**
Please print your Australian Visa Entitlement Verification Online (VEVO) or Visa Grant Notice.
3. **One completed [Visa Application Form](#)**
Please fill in all sections. If a question is not applicable, please put "N/A".
4. **One recent passport photograph (taken within the last 6 months)**
Australian standard-sized passport photo (4.5cm x 3.5cm) of good quality. If it is not a recent photo, please take a NEW photo and ensure it is printed on photo paper, NOT generic printing paper.
5. **Flight schedule shown with either a printed off screenshot of intended flights or flight confirmation**
A full flight schedule is required starting from Brisbane or Gold Coast, showing ALL transit destinations before and after Japan and returning to Brisbane or Gold Coast. If you will move to another state or country and will not be returning to Australia as the final destination for your trip, please submit a letter specifying those details.
6. **A visa for the next country that you will visit after Japan (if applicable).**
7. **A copy of your last Japanese visa stamp/sticker (within the last 3 years)
OR a copy of your Japan and G7 country visa (within the last 3 years)**

8. A copy of the Japanese landing permission stamp (within the last 3 years)

OR Japan and G7 country landing permission stamp (within the last 3 years)

(This is what you receive at the Immigration counter once you land in Japan showing which day you landed.)

9. A letter stating why you would like to obtain a multiple-entry Visa and why a single entry will not suffice

At least half an A4 length letter and typed, not handwritten. Including details of your interest in Japan, future plans to go to Japan and why you would like to apply for the multiple-entry visa. For families, each person's letter must be different and in their own words (including children although parents can help young children with their letters).

10. Documents to substantiate your financial capabilities (A, B and C are ALL required):

(Documents must show your full name as per your passport)

- A)** Bank statement or **transaction records** (savings) for the last **6 months** up to the day of your application, including the current balance, current address and your full name. The current balance must show sufficient funds for the trip to Japan.

✧ *Any large amounts of deposits must be verified with extra documents.*

✧ *Constant transfers from your other account into savings will require you to also bring 6 months of the other account transaction records.*

****For spouses or minors whose names are not on the bank records, proof of relationship (marriage certificate for spouse or birth certificate for children), copy of their passport and a Letter of Guarantee is required.****

- B)** A copy of recent pay slips AND recent letter of employment showing your total **annual income (year-to-date income statements not accepted)**.

- C)** ATO notice of assessment (NOA) from the most recent financial year immediately preceding your application date which shows your total **annual income** e.g. if you apply in Feb 2026, then the NOA for 2024-25 is required, not 2023-24.

11. A PRINTED copy of your current, valid passport (passport information page).

For the spouse or children of individuals who are eligible for a multiple-entry visa, documents to prove the relationship, copy of the eligible person's passport and [Letter of Guarantee](#) are required.

For spouses - marriage certificate

For children - birth certificate

If they are not in English a translation is also required

***12. For those who will apply based on point (4.) of the ELIGIBILITY criteria, the following are also required:**

- A)** Copy of the family member's valid Japanese multiple-entry visa and their passport (information page)

- B)** Proof of relationship

For spouses - marriage certificate

For children - birth certificate

If they are not in English a translation is also required

- C)** [Letter of Guarantee](#) filled out by the spouse or parent. Must include full names (including any middle names) and signature matching the passport.

- D)** Document #10 must be submitted from both the applicant and the family member
